

The First Amendment Agreement of Australia and New Zealand Representative Employment Agreement

No. 65-078

This First Amendment Agreement of Australia and New Zealand Representative Employment Agreement, No.65-078, hereinafter referred as the "Amendment", is made on March 16th, 2023, at Thailand Convention & Exhibition Bureau, a public organization, having its office located at 25th and 26th Floor, Siam Piwat Tower, 989 Rama 1 Road, Pathumwan Sub-district, Pathumwan District, Bangkok, 10330 by and between:

Thailand Convention & Exhibition Bureau (Public Organization), having its office located at 25th and 26thFloor, Siam Piwat Tower, 989,Rama 1 Road, Pathumwan Sub-district, Pathumwan District, Bangkok, 10330, represented by the authorized person, Mr. Chiruit Isarangkun Na Ayuthaya, President, hereinafter referred as "TCEB", of the one part, and

CLOCKWISE CONSULTING PTY LTD, company registration number is 617150704, which has registered as a juristic person at Australia, having its principal office located at 33 Middle Street, Ascot Vale, VIC 3032, Australia, represented by the authorized person, Ms. Nicole Tingey, who held the passport's number PA2013102, hereinafter referred as "the Representative" on the other part.

TCEB and the Representative have entered into the Australia and New Zealand Representative Employment Agreement, No. 65-078 dated October 3rd, 2022, hereinafter referred to as the "Agreement"

Whereas the Agreement is provided as the Representative of TCEB in the Region of Australia and New Zealand and TCEB is desirous to enhance additional activities ,which Australia Sales Mission 2023 hereinafter referred to as the "Event", whereby TCEB considers that the Event will increase more sales and marketing opportunities for Thai MICE stakeholders in Australia and New Zealand market and build greater awareness of Thailand and uplift the image of the country as an outstanding convention destination.





Now, therefore, both parties agree to enter into this Amendment as follows;

Clause 1 The Representative agrees to be engaged to carry out the additional activities, which Australia Sales Mission 2023, as detailed in the Terms of Reference (Scope of Work) in Appendix 1.

The Representative is obligated to perform the Event as required by TCEB for a period of 150 days after the Amendment signed date.

Clause 2 In the addition of the activities under Clause 1, TCEB agrees to pay and the Representative agrees to accept the payment of AUD 29,442.66 (twenty-nine thousand four hundred forty-two Australian dollars and sixty-six cents). This amount is inclusive of value added tax, other taxes and duties, and all expenses.

TCEB shall effect payment to the Representative, in accordance with the term of payment which set forth in Appendix 1 and Appendix 3, the payment will be made the following:

- 1) The 1st payment of AUD 4,416.40 (four thousand four hundred sixteen Australian dollars and forty cents) (Thailand's VAT included), which is equal to 15% (fifteen percent) of the total payment, shall be paid to the Representative when the Representative delivers the 1st delivery of the work set forth in Appendix 1 and Appendix 3 of this Amendment.
- 2) The 2nd payment of AUD 10,304.93 (ten thousand three hundred four Australian dollars and ninety-three cents) (Thailand's VAT included), which is equal to 35% (thirty-five percent) of the total payment, shall be paid to the Representative when the Representative delivers the 2nd delivery of the work set forth in Appendix 1 and Appendix 3 of this Amendment.
- 3) The last payment of AUD 14,721.33 (fourteen thousand seven hundred twenty-one Australian dollars and thirty-three cents) (Thailand's VAT included), which is equal to 50% (fifty percent) of the total payment, shall be paid to the Representative when the Representative delivers the 3rd delivery of the work set forth in Appendix 1 and Appendix 3 of this Amendment.

The payment herein above will be made after the delivery work is submitted in accordance with Appendix 1 and TCEB's inspection committee or representative has inspected and accepted such the Work.

Clause 3 In entering into this Amendment, the Representative has provided to TCEB, an additional performance bond, covering the amount of AUD 1,480 (one thousand four hundred eighty Australian dollars), as a performance bond under this Amendment.





The performance bond that the Representative shall provide according to the preceding paragraph, must cover all liability of the Representative throughout the Amendment period. If the performance bond provided by the Representative is reduced or deteriorated or does not cover the liability of the Representative throughout the Amendment period, for any reason, including the delay in work delivery of the Representative that cause change of the completion period or the due date of liability for defects under the Amendment, no matter what time it occurs, the Representative shall provide TCEB with new or additional performance bond to the full amount under the first paragraph within fifteen (15) days from the day after the receipt of a written notice from TCEB.

TCEB will return performance bond provided by the Representative under this Amendment to the Representative without interest after the Representative is discharged from all obligations and liabilities under this Amendment.

Clause 4 The following the Appendix shall be regarded as part of the Amendment;

- 4.1 Appendix 1 Term of Reference (TOR), all 5 (five) pages.
- 4.2 Appendix 2 Proposal all 4 (four) pages.
- 4.3 Appendix 3 Quotation all 1 (one) page.

Clause 5 Other than the amendments under this Amendment, other terms and conditions shall be as set out in the Agreement in all respects.

Clause 6 The Amendment shall be effective from March 17th, 2023 onwards

Clause 7 If there is any conflict between the provisions of the Agreement or its appendix or the Amendment or its appendix, the Representative agrees that the TCEB shall have the discretion to make a decision. The decision of the TCEB shall be considered final and the Representative agree to strictly comply with the decision of the TCEB in all respects.

The parties have read and thoroughly understood the contents of this Amendment, the parties find that it meets their intention, and therefore have signed their names and affixed their corporate seals (if any) below in the presence of witnesses. 8. Qualifications of the Contractor

Section 64: Subject to section 51 and section 52, a person who intends to tender a proposal in procurement with a State agency must at least have the qualifications and must not be under prohibitions, as follows:

11. Payment terms

TCEB shall pay contractor for the provision of the services after each work is submitted and approved by the Acceptance Committee.

- 11.1 The 1st installment, TCEB will pay 15 percent of the total wage after the 1st delivery is complete. The payment schedule will be considered after the approval of the acceptance committee and has been signed by the approval authority only.
- 11.2 The 2nd installment, TCEB will pay 35 percent of the total wage after the 2nd delivery is complete. The payment schedule will be considered after the approval of the acceptance committee and has been signed by the approval authority only.

11.3 The 3rd installment, TCEB will pay 50 percent of the total wage after the 3rd delivery is complete. The payment schedule will be considered after the approval of the acceptance committee and has been signed by the approval authority only.

12. Performance bond

The contractor has to provide a performance bond to TCEB in the amount of not less than 5% of the purchase or contract price.

13. Stamp duty

The contractor has to pay the cost of affixing stamp duty, in accordance with the Revenue Code, Stamp duty charges for services in the amount of 1 baht of every 1,000 baht or a fraction of 1,000 baht of the remuneration prescribed or part thereof.

14. Fine Rate

TCEB stipulates conditions in the event that the contractor is unable to deliver the work within the time specified in the scope of work, with a daily fine at the rate of 0.1 percent of the value of the undelivered parcel/the value of the employment, but not less than 100 baht per day.

15. Cancellation

TCEB reserves the right to cancel the procurement, employment or contract in the event that it is determined that the most or almost of the contractor's work under the scope of work has been delayed and causes damage, the acceptance of such work is useless, the lack of ability to perform tasks in accordance with the scope of work or the contract for quality and completion as scheduled. TCEB will not be responsible for any expenses incurred to the contractor and if such circumstances cause TCEB damage, the contractor must be responsible and compensate for the damage caused to TCEB also, without any conditions at all.

16. Ownership of data and documents

Documents/data/workpieces/databases and/or software and anything else that results from the implementation of this project, all work that has been performed, including those that have been delivered and that have not been delivered, shall be the property of TCEB by law, which the contractor must deliver to the TCEB and TCEB has the right to take part or all of the work to be published or reproduced by itself or allow others to publish or reproduce.

17. Personal Data Processing

In case the Contractor is the personal data processor for or on behalf of the Employer, then, the Contractor shall strictly keep the personal data confidential, and shall maintain the security measurement for personal data processing as prescribed by the Personal Data Protection Committee and/or in accordance with the international standard for personal data protection.

The Contractor shall conduct the processing and keep the record of all personal data processing activities (Record of Processing) performed by the Contractor within the scope of work only and the data as specified below, and shall deliver such record to the Employer upon the termination of Agreement.

TCEB reserves the right not to hire the contractor, if it appears that the submission of the proposal does not meet the criteria or conditions specified, or TCEB considers that the employment of such selected person will not be beneficial to TCEB as it should. The expenses of the proposer arising from the selection process for the price examination shall be the burden of the proposer, and the proposer has no right to claim any damages from TCEB.

19. Sub-contracting

The contractor has not right to sub-contract the works under this contract, whether in whole or in part, except for partially sub-contracting that have been permitted in writing from TCEB. Permission to partially sub-contracting from TCEB does not release the contractor from liability or obligation under this contract and the contractor shall be liable for the fault and negligence of the sub-contractor or the sub-contractor's representatives or employees in all respect.

In case that the contractor has partially sub-contracted in violation of the provisions of the first paragraph, the contractor shall pay fine to TCEB at the rate of 10 percent of the amount of the sub-contracted works, without prejudice to TCEB's right to terminate this contract.

Remarks:

- 1. The decision of TCEB is deemed to be final. The proposers who have not been selected shall accept and shall not dispute the decision of TCEB in any case at all.
- 2. TCEB reserves the right not to choose the lowest proposer, but it will consider from the criteria used in the overall selection process.
- 3. The selected proposer must work along with TCEB. Any decision-making must be obtained the prior consent from TCEB.
- 4. TCEB reserves the right to negotiate the prices with the proposer, whether before and/or after TCEB has decision.
- 5. TCEB reserves the right to modify or add content as appropriate with the consent of the selected proposer.
